National Fruit at Work Day and The FruitGuys present: 2016 Fruit Crown Photo Contest Rules

Sponsor: The FruitGuys ("TFG"), 490 Eccles Avenue, South San Francisco, CA 94080 USA

How to enter:

- The National Fruit at Work Day (NF@WD) Fruit Crown Photo Contest begins on September 9, 2016, at midnight PST and ends on October 4, 2016, at 5pm PST. Any U.S. resident, 18 years of age or older, is invited to submit one (1) photo per day.
- Participants can submit photos by posting on NF@WD's social media channels (**@fruitatworkday** on Facebook, Instagram, and Twitter) and including the hashtag **#fruitatworkday**.

Contest Overview:

- There will be a single Grand Prize Winner chosen from all photo Submissions (to be selected by an internal TFG Contest Committee). Ten additional Participants will be selected at random to receive a secondary prize (see "Contest Prizes" below for prize details).
 - § NOTE: If any winning photo is submitted by a team of multiple individuals, the prize will be shared among Participants.
- Participants who have submitted winning entries will be asked to supply their work email address and physical business address. If the entry is submitted by a group, we will need the work email address and physical business address from one contact person in the group.
 - § By entering this Contest, Participants agree to have their name used publicly for the purposes of promoting the Contest and announcing a Winner of the Contest.
 - § No purchase or payment of any kind is necessary to enter or win.
- ALL PRIZES MUST BE REDEEMED BY DECEMBER 31, 2016, AT 5PM PST.

Photo Criteria:

- In your office, take a selfie, group shot, or "Where's Waldo?" style photo featuring the Fruit Crown (preferably on someone's head).
- Limit: You may enter one (1) photo Submission per day during the Contest period.
- Participants may NOT submit any photo that (i) contains offensive, pornographic, obscene, libelous, defamatory, threatening, abusive, criminal, or adult themes, links, or images; (ii) violates or encourages anyone to violate any law or regulation; or (iii) contains advertising or commercial messages.
- Submissions must be less than 2MB and in .jpg, .png, or .gif format.
- Submissions must be the sole and original work of the Participant (individual or group), and the Participant represents and warrants that the Participant has full right, title, and interest to the Submission. The Submission must not infringe upon the rights of any third party, including but not limited to copyright, trademark, privacy, and personality rights. By making a Submission, you waive any rights you may have in such Submission.
- Submissions not meeting these criteria shall be disqualified. Additionally, TFG reserves the right to disqualify Submissions for any other reason.

Contest Prizes:

- One (1) Grand Prize Winner (individual or group) will be selected from the Participants to win a Medium Organic Harvest Fruit Box weekly for one (1) year (52 boxes total). Prize must be redeemed by December 31, 2016, at 5pm PST.
- Ten (10) Participants will be chosen at random to receive an Organic SmileSnack Fruit Box: 9 pieces of organic farm-fresh fruit. Prizes must be redeemed by December 31, 2016, at 5pm PST.
- TFG reserves the right to select fewer than ten (10) SmileSnack Winners, if, in its sole discretion, it does not receive a sufficient number of eligible and qualified Submissions.

• Prizes must be accepted as awarded. Prizes are non-transferable and non-redeemable for cash. Prizes may not be exactly as shown in promotional materials. In case of unavailability of any Prize, or for any other reason and in TFG's sole discretion, TFG reserves the right to substitute a Prize of equal or greater value.

Determining Winners:

- There will be only one (1) Prize awarded to each individual Winner or winning team. The Winners will be selected as follows:
- The Grand Prize Winner will be selected by an internal TFG Contest Committee.
- The ten (10) SmileSnack Winners will be selected at random from the remaining Participants.
- In the event no Submissions are received fitting the Contest criteria, no prizes will be awarded.

Contacting Winners:

- Winners will be contacted by email as provided by the Participant within five (5) days of the Contest closing. If the Winner is unable to be contacted after three (3) attempts by November 1, 2016, at the sole discretion of TFG, he or she will forfeit the Prize and another Winner will be selected as set out herein.
- By entering this Contest, Winners agree that their name and winning Submission can be announced on TFG and NF@WD social media channels, nationalfruitatworkday.com, and/or fruitguys.com after they have been notified of their winning entry.

Eligibility:

- Contest opens at midnight PST on September 9, 2016, and closes at 5pm PST on October 4, 2016.
- The Contest is open to U.S. residents only.
- Participants must be at least 18 years of age to enter this Contest.
- Participants are eligible to enter up to one (1) photo Submission per day. Only Submissions that adhere to the guidelines and restrictions as laid out herein are eligible for this Contest. Participants may be required to provide evidence of their eligibility to enter this Contest.
